AvGas / Leaded fuels

I spoke with a representative of Environment Department (Fuel Quality Standards Section) on 1st December; they advised the Minister was considering phasing out AvGas and leaded fuels. I referred them to Terry Thompson as I consider this is his field of expertise as he is involved with the historic racing and their use of leaded fuels.

On 10th December the Minister for the Environment decided to begin a phase out of leaded racing fuel. The Minister granted a 1 year approval to the most recent leaded racing fuel applicants, and advised in a letter (see attached) that "it is the Government's intention to consider phasing out lead in racing fuel over one or two years, beginning in 2017".

The Minister also noted the Department would be in touch with suppliers and racing associations to seek their views on the phase out timeframe and how the industry might need to adjust to its practices.

USA are working on a replacement for AvGas and this is expected to be available in 3 to 4 years and they can then drop in the replacement for the aeroplanes. They are removing the availability to motor vehicles prior to the aeroplanes due to the "concentrated and localised emissions of lead from cars".

Lobbyist in Canberra
