### **UPDATE ON COUNCIL COORDINATED/RUN/HOSTED EVENTS:**

Council annual rally held in Albury/Wodonga in May 2017 was well organised. Entries came in from all over NSW & some from Victoria. This event was over the weekend of the National Motoring Heritage Day which also attracted a large number of participants. Numbers were down on previous rallies.

It was also the AGM meeting of the CHMC where two (2) new clubs were affiliated. One of the new clubs from the Maitland area has a membership exceeding 200 & over 500 motor vehicles.

### **RESTRICTED/CONCESSIONAL REGISTRATION UPDATE:**

The Classic Vehicle Scheme (CVS) is now up & running. The CHMC has now been accepted by the RMS as an **Approved Organisation**. CHMC has appointed Mr W. Waddell as the **Responsible Person** heading a management committee of seven (7). To date we have only received about 8 applications for CVS of which two (2) have been eliminated due to being **WELL** outside CHMC guidelines for a Heritage/Historic/Authentic vehicle.

### **COUNCIL NEWSLETTER & WWW ARTICLE HIGHLIGHTS:**

The notification that L, P1 & P2 drivers in NSW, not being able to drive ANY vehicle that is not fitted with seatbelts from November 2017, will be detrimental to the movement. This is being taken very seriously by CHMC & are seeking a Ministerial exemption for these drivers of HVS vehicles. Currently we have several letters to local members re this issue as well raising it personally with the Minister for Roads.

### **NATIONAL MOTORING HERITAGE DAY EVENTS – PLANS/DETAILS:**

There were several events throughout NSW held on this day. The display at Albury/Wodonga, a motoring extravaganza held at Tamworth, hosted by Rotary & supported by many clubs from the north west/new england areas.

### **UPDATE RE NATIONAL EVENT/RALLY 2020:**

Parkes half year meeting held 29/10/2016 came up with a few ideas. The main thoughts were to be able to host those travelling through their locations. This will all depend on which route the travellers from Qld & Northern NSW take. Either the New England, Pacific or the Newell highways. Distances to be travelled by what category of vehicles. I will have some figures re distances & clubs willing to host or do whatever they can to assist by the meeting.
