Everyone introduced themselves and their organisation

There followed discussion of the current situation facing the different organisations and the opportunities that exist to work together to make improvements.

From this point the Minutes do not follow chronological order. I have included individual comments under the key initiatives that we agreed to focus on.

1. Regulation

- a. Reduce the perceived risk that is driving increased regulation
- b. Engage with regulatory bodies to convince them that we are responsible
- c. Examples of concern are:
 - i. Movable Heritage Act and Regulations
 - Too many significant items being exported
 - Difficult to take items overseas for rallies and then bring them back (also customs issues)
 - ii. boiler certification
 - iii. legislation doesn't differentiate between employee and volunteer
- d. Investigate opportunity for heritage lottery or similar

2. Skills and training

- a. Engage with TAFE and trade training organisations to promote heritage trades
- b. Need to identify which trades and skills
- c. Investigate centres of excellence to preserve knowledge and share expertise

3. Access to workshop and technical resources

- a. Don't need everyone to have every capability – specialise and share
- b. Include standards and technical documentation

4. Community relevance and engagement

- a. Need to confirm link between heritage and tourism
- b. Need to engage younger people
 - i. may be too late to attract over-30s
 - ii. maybe better to focus on under-30s and older people with time available (children just left home or planning to retire)
 - iii. some organisations offer prizes for young restorers
 - iv. don't just focus on kids
- c. Need to be more active with different types of media, particularly social media
- d. Need to consider different types of heritage experience eg. live feeds of activities for those who experience the world through their devices
- e. Need to engage with governments, particularly in areas of tourism, heritage and trades training
- f. Engage with people who have valuable skills (not just restoration and operation) eg.
 - i. administration
 - ii. marketing
 - iii. finance

5. Indemnity insurance

- a. Engage with insurers to convince them that risk is not as high as is believed (that risk minimisation strategies and procedures are enforced)
- b. Investigate ways for retired engineers to provide engineering advice without needing to pay high personal insurance

It was agreed to establish 5 sub-groups to investigate the five subjects above and report back to this group with their analysis and recommendations.
